



## GENERAL CONDITIONS OF VINTAGE BEL AIR CLUB ® MEMBERSHIP

Please read carefully the General Terms and Conditions of Club Vintage Bel Air® membership. The Club membership is open to all individuals who have reached the age of 18 and older and who share the values of Club Vintage Bel Air®. All you have to do is to fill out the form of registration and submit membership fees.

### Membership cost:

- We charge a fee of 500€, all taxes included, for individuals or 1200€, all taxes included, for corporate entities.
- Membership fees to be paid all at once.
- Those to be settled by the means of secure online payment or by cheque payable to "Vintage Bel Air". The latter to be sent to 1, rue du Docteur Lavirotte, 21340 Nolay accompanied by a membership form filled out, dated and signed by a subscriber.
- An annual fee for an individual entitles the holder to one membership. An annual fee for a corporate entity entitles the holder to two memberships.
- An invoice will be issued by Vintage Bel Air® to all subscribers.

### The effective date and membership duration :

- The membership will be effective after cashing of the payment made to Vintage Bel Air® by a subscriber
- The club membership requires full compliance with the general conditions defined above.
- The membership is valid until 31 December 2019. It will end automatically on 15 January 2020 unless the renewal is requested by a member.

- The membership is set for this fixed period and can not be stopped before 31 December 2019. Neither refund nor membership postponement will be granted once the payment has been made. No interruption of user access to membership offers and advantages will be compensated or reimbursed.
- From 2020 onwards, an annual contribution will be required to extend the membership. Simple notification of a renewal request will be sent to all members by Vintage Bel Air® about one month before 31 December 2019.

### **Right of access and rectification :**
